- If your appointment is canceled more than three (3) business days in advance, your deposit will be fully refunded.

Note: Deposits for commercial vehicle wrap appointments are non-refundable at all times, regardless of notice given.

When Deposits Are Required

- Any scheduled service with a value of \$1,000 or more
- Other appointments may also require deposits depending on the type of service, seasonal demand, or other circumstances.
